Individual Membership

The Association distinguishes the following Membership types for individual Members:

1. All Individual Memberships start upon acceptance by the Association. Acceptance will not be withheld unreasonably and may be confirmed in an automated process
2. Basic Membership ends immediately upon:
 - a) Termination by the Member at any time.
 - b) The registered email address has become invalid and no new email address has been registered by the Member.
 - c) Termination by the Association for cause.
3. Standard Membership ends at the end of the calendar year upon:
 - a) Termination by the Member at any time.
 - b) The registered email address has become invalid and no new email address has been registered by the Member.
 - c) Termination by the Association for cause.



d) The death of the Member.

4. Student Membership ends at the end of the calendar year upon:

a) Termination by the Member at any time.

b) The registered email address has become invalid and no new email address has been registered by the Member.

c) Termination by the Association for cause.

d) The death of the Member.

e) The Member no longer qualifies for Student Membership, for example after completing or aborting their study.

f) After a maximum Student Membership of two years.

5. Discount for paid events for Student Members is determined per event and will be announced with the other event pricing.

6. Membership fees are payable upfront, either at the time of registration for new Members, or before 15 January for following years. In case the Membership fee is not received by the 31st of January, the Association reserves the right to suspend the Membership. In case the Membership fee is not received by the 28th of February, the Association reserves the right to terminate the Standard Membership with immediate effect and convert it into a Basic Membership.

7. Suspension of Standard Membership means that the suspended Member temporarily has no more rights than a Basic Member, most notably no discount vouchers and no vote in the General Assembly.

8. Discount vouchers have to be redeemed in the calendar year for which they are issued and expire at the end of that year.

9. "Introduce a friend" Bonus: When a Member uses a discount voucher to provide discount for an event for a non-Member, and that non-Member signs up for a Standard Membership within one month after the end of the event, the Member will receive one new discount voucher.

1. Corporate Membership ends at the end of the calendar year upon:

- a) Termination by the Corporate Member at any time.
- b) The Corporate Member becomes insolvent.
- c) Termination by the Association for cause.

2. Corporate Membership continues automatically until terminated.



3. Membership fees are payable upfront. The Association will provide the Corporate Member with an invoice for the Membership fee. In case the Membership fee is not received within the payment term, the Association reserves the right to suspend the Corporate Membership until payment is received. The Association will use established industry practices for late payments. When payment cannot be collected from the Corporate Member, the Association reserves the right to terminate the Corporate Membership with immediate effect.

4. Suspension of Corporate Membership means that employees of the suspended Member temporarily have no more rights than a Basic Individual Member, most notably no discount vouchers and no votes in the General Assembly.

5. The Corporate Member may be represented towards the Association and during the General Assembly by a maximum of two senior managers or duly authorised employees.

6. Officers and employees of the Corporate Member register individually as Members and will automatically be recognised as belonging to the Corporate Member by the use of their corporate email address.

7. Discount vouchers have to be redeemed in the calendar year for which they are issued and expire at the end of that year.

8 "Introduce a friend" Bonus: When a Corporate Member uses one or more discount vouchers to provide discount for an event for a non-Member, and that non-Member signs up for a paid Membership within one month after the end of the event, the Corporate Member will receive one new discount voucher.
